1. Purpose of the Agreement

2. Acknowledgment of Opportunity

The Player understands that participation in the showcase may lead to opportunities for professional
tryouts, trials, or contracts with domestic or international clubs. **Intelisport**, through its global network,
is committed to presenting participants who demonstrate qualifying ability to club partners and
intermediaries.

3. Conditional Representation Commitment

Should the Player be selected by a club or receive a formal opportunity for trial, tryout or contract
negotiation as a direct result of participation in the showcase, the Player agrees to sign an exclusive
representation contract with **Intelisport Global Football Agency**, authorizing **Intelisport** to act as their
exclusive intermediary and agent for all related negotiations and club placement.

4. Duration of Conditional Representation

The Player agrees that if selected, the representation contract with **Intelisport** will have a minimum
duration of 12 months, renewable based on mutual agreement.

5. Exclusivity

The Player acknowledges that no other individual, agency, or entity may act on their behalf in
discussions or negotiations resulting from the showcase without written consent from **Intelisport**.
Breach of this clause may result in removal from the program and legal recourse.



6. Confidentiality

Both parties agree to keep confidential any offers, opportunities, or agreements discussed during or after the showcase unless disclosure is legally required or mutually agreed.

7. Governing Law

This Agreement shall be governed by the laws of the State of Florida, USA. Any disputes shall be resolved under the jurisdiction of competent courts in Miami-Dade County.
